Definitions	
Affiliates	<p>Companies related by common ownership and control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>We may share information with our affiliates for our everyday business purposes, including information about your transactions and experiences.</i>
Nonaffiliates	<p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>We share limited information with a select group of nonaffiliates in cases where we believe their services may provide a benefit to you. Example: getting a quote for a mortgage for you if we believe your interest rate or terms could be improved upon.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or service to you.</p> <ul style="list-style-type: none"> ▪ <i>When we jointly market, we are selective about who is jointly marketed to and seek to jointly market only with companies we believe provide a meaningful benefit to our clients. When the exist, conflicts of interest are properly disclosed.</i>
